This paper explores the pioneering efforts of the Justice Party, formally known as the South Indian Liberal Federation, in introducing caste-based reservations in Tamil Nadu and shaping the state's socio-political landscape. Founded in 1916 by visionary leaders Dr. T.M. Nair, P. Theagaraya Chetty, and C.N. Mudaliar, the Justice Party emerged as a response to Brahmin hegemony in the Madras Presidency's administration, education, and employment sectors. At a time when rigid caste hierarchies restricted non-Brahmins' access to opportunities, the Justice Party advocated for affirmative action to foster social equity and inclusivity.

The party's landmark achievement was the implementation of the Communal Government Order of 1921, one of India's earliest examples of caste-based reservation policies. This policy reserved government jobs and educational seats for marginalized communities, setting a precedent for affirmative action. By democratizing education and employment, the Justice Party played a crucial role in empowering backward classes and reducing caste-based disparities in Tamil Nadu. The paper highlights the far-reaching impacts of these reservation policies on Tamil Nadu's socio-economic development. The Justice Party's initiatives laid the foundation for political empowerment and economic upliftment of backward communities, fostering their participation in governance and public services. These efforts also inspired the rise of the Dravidian movement led by Periyar E.V. Ramasamy and influenced national-level debates on reservation policies, including the recommendations of the Mandal Commission in the 1990s. Despite its contributions, the Justice Party faced criticism for being initially dominated by non-Brahmin elites and accusations of neglecting the poorest sections of society. Internal divisions and resistance from conservative groups posed additional challenges to its efforts. Nevertheless, its legacy continues to shape Tamil Nadu's comprehensive reservation policies and serves as a model for social justice reforms in India.

- Employment Quotas: A specified percentage of government jobs were reserved for non-Brahmins, Scheduled Castes, and Scheduled Tribes.
- Educational Reservations: Seats in educational institutions were allocated to underprivileged communities.
- Gender Considerations: Although primarily focused on caste, the Justice Party also advocated for women's education and employment.

The Justice Party's initiatives laid the groundwork for constitutional provisions on reservations. Articles 15(4) and 16(4) of the Indian Constitution, which allow for affirmative action, reflect the principles championed by the Justice Party.
